## Alteris Renewables - Loudonville Home for Adults -

Olya Previo and Dennis Phaire made a presentation on the installation of a solar panel project under the Alternative Energy Program. The installation will be a 52khw system. Currently the project is before National Grid and NYSERDA for their approvals – upon receipt of such approvals the IDA Board will be able to act on project.

## **Audit Committee:**

A motion to approve and move towards payment for both vendors was made by Member DeLuca and 2<sup>nd</sup> by Member Burgess.

## 272 Maxwell Road:

Members were updated as to the process for disposition for the former CYC Office building lo cated at 272 Maxwell Road. A notice will be in the paper looking to solicit offers for the location. If no offers are received the next step would be to draft an RFQ and select a realtor to sell the parcel.
